- c. New Gym Service proposal was renewed for a year's worth of preventative maintenance visits. Schedule first quarter of new Gym Services contract for the end of January 2016
- d. GSA outlet issue Need GFI outlets near lockers in both locker rooms? Bruce -GSA/Work Inc. staff removed box fans from locker rooms because the electrical outlets are not GFI. Yet GSA advised the MFC to use box fans for ventilation in the locker rooms. Need to consult GSA on way forward Bruce?

- a. A proposal to give Dr. Bruce Cohen, our part time fitness specialist at the MFC, a \$5.00 pay increase. This would increase Bruce's salary to \$55.00 per hour. This motion was seconded and unanimously approved via email on November 4. Seven board members voted.

- c. Insurance policy renewed with B.R. Alexander (Hugh Martinez)
- d. Posting of meeting minutes to website only need a password to post minutes, Phil to advise next month.

8. Summary/things to do:

- Prepare for new fiscal year/2016 membership drive revise applications and advertise membership renewal (late November). Ariel will create 2016 application and Bruce will review and revise.
- 2. Prepare annual report for MA Secretary of State and file with \$15 fee (due in Nov.)
- 3. December Board Meeting December 8, 2 pm.
- 4. Request to install another pull up bar high enough for tall members to hang from. Nothing wall mounted allowed on external walls or non-load-bearing interior walls.

- 6. Request to make sure that heaviest dumbbells are placed on top rack to prevent back injuries. Bruce has put up a sign.
